3. Dean's Lecture Schedule, Plan Finalizing, and Announcement. DOE Assistant Secretary Patricia Hoffman, Office of Electricity Delivery and Energy Reliability is scheduled to visit ASU campus and present a seminar on Wednesday, April 22, 2015 in the Marston Exploration Theatre. Additionally, AS Hoffman will meet with Engineering faculty and administrators. A save-the-date announcement was placed in *In the Loop* and the student e-pub, *Inner Circle*.

4. Post-Tenure Document Revision Follow-up with Dean. The revised document was submitted to Dean Johnson. The committee has not received any additional feedback yet.

5. Faculty Evaluation. This committee was tasked with determining if there is a way to streamline the faculty evaluation process across all six schools. There seems to be two distinct questions being answered with the annual evaluation. First, related to post tenure review: Is the minimum threshold for satisfactory performance being reached? Second, related to meritorious performance: What do the directors need to know in order to decide on raises? Some of the information required is easy to compile; some of it isn't. A large data set is probably needed to

demonstrate unsatisfactory performance, whereas fewer data may be sufficient to assess superior performance. Some units require both data and written statements; others don't. Perhaps data collection should be synchronized with the fiscal year to make it easier for the administrative assistants to collect. Ultimately, all six units should follow the same process. The committee will poll directors to determine what factors actually influence their decisions in an effort to aid in establishing more uniform practices across the Engineering Schools.

ACTION ITEM: Committee will discuss with their faculty and determine way to poll directors
